
# **Altamont After School Program**

# 1960 First United Fund Campaign

It all began at a Rotary meeting 61 years ago. In late October of 1960, a group of Effingham Rotarians and individuals decided that something needed to be done to combine the fundraising efforts of different organizations in Effingham County.

The co-chairpersons in 1960 were Clinton Cutright, Effingham County Farm Advisor, George Kraft, and Clifford Stevens. The first United Fund directors were Raymond Althoff of Effingham, O.V. Bradham of Mason, Merl Magnus of Beecher City, D.L. Wetherell of Shumway, Mrs. Grant Fritscher of Dieterich, John O'Tain of Altamont, and Mrs. Herschel Broom of Mason.


More than \$30,000 was raised that first year. At the time, the public school system was not required to help special needs children and the directors learned of the need for a program that would help these children. At the end of the first drive, the new United Fund allocated \$500 to a committee headed by Nanon Wood to help handicapped children. This group started a school, later called the Achievement Center. The group then moved to the bowling alley on North Third Street in Effingham and was called the Opportunity Center. At present this service center is located in Teutopolis and is known to us all as ARC Community Support Services.

The goal the second year was \$36,000 and allowed the United Fund to give St. Anthony Hospital three pieces of needed equipment. For a number of years, total giving to the fund was around \$50,000.

# 2021 United Way of Effingham County campaign raises \$261,324 as global pandemic continues!



The 2021 campaign continued to be a challenging year as the Covid-19 global pandemic continued. The coronavirus disease created new strains to include the Delta and Omicron variant which were highly contagious. All fundraiser events were again cancelled for the health and safety of the community to include; Barstool Golf, Jennings Labor Day Celebration and the Witches Ball. The virtual Thanks & Giving raffle was once again held to help make up for the loss of funds raised by our previously scheduled in person fundraiser events. The 2021 campaign raised \$261,324 which was 82% of the \$320,000 goal. We are pleased with the amount raised, despite the continued challenges faced due to the Coronavirus disease.

The 2020 campaign also fell short of the \$320,000 goal but an anonymous generous donor donated \$46,784 to make up the shortfall! That campaign raised \$320,336.

The Board of Directors would like to thank everyone who contributed to the 2021 campaign during these unprecedented times! Funds raised will help 21 local partner agencies provide support and services to those in need in Effingham County.

# **Employee Campaigns**

Over 85% of the annual campaign is generated from employee campaigns with the remainder coming from fundraiser events. This year due to the global Covid-19 pandemic and mandated restrictions, the following events were cancelled; Barstool Golf, Jennings Labor Day Celebration and the Witches Ball. The Covid-19 pandemic also affected the Grants Committee timeline and process. Original grant requests were due 4/6/20 with presentations scheduled for 4/27/20 and 5/11/20. When the pandemic hit and government mandated restrictions were issued, the meetings could not be held. We were at a stand still and uncertain what the 2020 campaign would look like as many businesses had employees working remotely or were shut down due to the pandemic.

Illinois Covid-19 Response Funds were made available because of the global pandemic. These funds were established by United Way of Illinois and the Alliance of Illinois Community Foundations and made available for our area. United Way of Effingham County worked with the Southeastern Illinois Community Foundation to distribute these funds, A total of \$250,250 was issued to Effingham County agencies to help provide support and services to those in need during these pandemic times.

Grant presentations were later held in September, 2020 and agencies were asked to submit an addendum noting their new grant request. Some agencies asked for more, many requested less because of funds received from the Covid-19 Response Fund, and several omitted their original request as they were unable to operate due to the pandemic and mandated restrictions that continued. Estimated payouts were then determined based on the new grant request from the agencies.

Payouts are distributed based on the estimated funds an agency is assigned by the Grants Committee. In the event the goal is exceeded, an agency will receive more funds, but will not receive more than originally requested.

One agency is currently fully funded, with the anticipation that a few others may be fully funded once actual uncollectibles are determined. Final payout will be issued in March, 2022, and will be paid on actual uncollectibles.
